

William Thomas. He and his widow Elizabeth were married in Hanover County by Charles Shepperson 23 November 1815. She was Elizabeth Meanley (?). William served from August 1814 to October 1814 when he got his brother John Thomas to act in his place. William died in 1828.

Chesley Thacker. Mary Thacker was his widow. She was married in May 1814 and he died 25 August 1845. He served under Captain Hudson Wingfield's company of Hanover County.

Thomas J. Thompson. Sarah Thompson, widow. Henry Thompson, son, received 160 acres in Missouri.

Reuben Throgmorton. His widow Sally was a resident of Staunton, Augusta County. He was a substitute for Ralph Crutchfield. Sally Throgmorton's declaration was dated 2 August 1856, aged 64 years. They were married in the city of Richmond 11 May 1811 by the Rev. Mr Buchanan, and she was Sally Hughes before her marriage. Her husband died in Richmond 2 August 1827.

Hezekiah Thurman. Nancy Thurman aged 63 in 1860 was the widow of Hezekiah Thurman and a resident of Chesterfield County. He served in the company commanded by Flournoy and Weisiger. They were married in Chesterfield County 15 April 1813 by the Rev. Daniel Hudson. Hezekiah died 6 January 1840.

Jacob Trueman. Bounty land claim by Jacob Trueman of Henrico County aged 62 in 1855, who was a substitute in the company of Captain Robert L. Coleman, 8th Regiment of Virginia Militia.

James T. Tibbs. Power of Attorney granted to John B. Tibbs (son) of Henrico County as guardian for the children of James T. Tibbs who were Alpheus Lowry Tibbs and Demarcheus Jackson Tibbs, minor children . . . to act for them in obtaining bounty land. Mary, wife of James Tibbs, also deceased.

Tice M. Tibbs. Postal card gives his name as Mannoah, Manonot, Manasset and Mannassah. His widow was Cinthia. He served in Captain William Currin's company from 13 February 1815 to 28 February 1815.

Jacob Tingler. Correspondence from Rice Patch, Allegheny County, by Davis M. Humphries on behalf of Barbara Tingler, Jacob's widow. Jacob died 4 April 1868 in Allegheny County. He resided in Botetourt County when he enlisted. He was the son of Michal Tingler. They were married 14 September 1867 in Allegheny by the Rev. John B. Davis. She was Barbara Fogle before her marriage, and was the deserted wife of George Fogle. Jacob's first wife was Margaret Persinger, and she died 4 July 1859 in Craig County. ". . . it is further more known that George Fogle married Barbara Quickle in or about 14 February 1856 in Allegheny County and that he deserted his wife in 1858 and has not been heard of since 1861 and supposed to have long since died."
