

Constructing a Drury Grissom Family Structure

Introduction

Initially, the motivation for this investigation into the Drury Grissom family began with Mary Grissom. Mary's lineage as the daughter of Drury and Mary, i.e. Mary Sr, was verified after collecting and analyzing a wide variety of ancestral documents.^{1 2 3 4} In the 1790 Lincoln County North Carolina (NC) Census, Drury was the lone Grissom enumerated, residing alongside John Glen and John Beard.⁵ Daughter Mary, i.e. Mary Jr, married John Glen after 27 May 1797 in Lincoln County NC^{6 7} and were the parents of two daughters, Elizabeth^{8 9} and Rachel.^{10 11} Mary Jr was last reported in 1836 to be very ill and domiciled at the residence of son-in-law Elijah Brown in Spartanburg County South Carolina (SC).¹²

Drury was a yeoman, laborer,^{13 14} who along with wife Mary Sr^{15 16} resided on 200 acres of Mill Creek land granted to John Baulsh of Tryon County NC on 15 May 1772.^{17 18 19} Drury and Mary Sr were

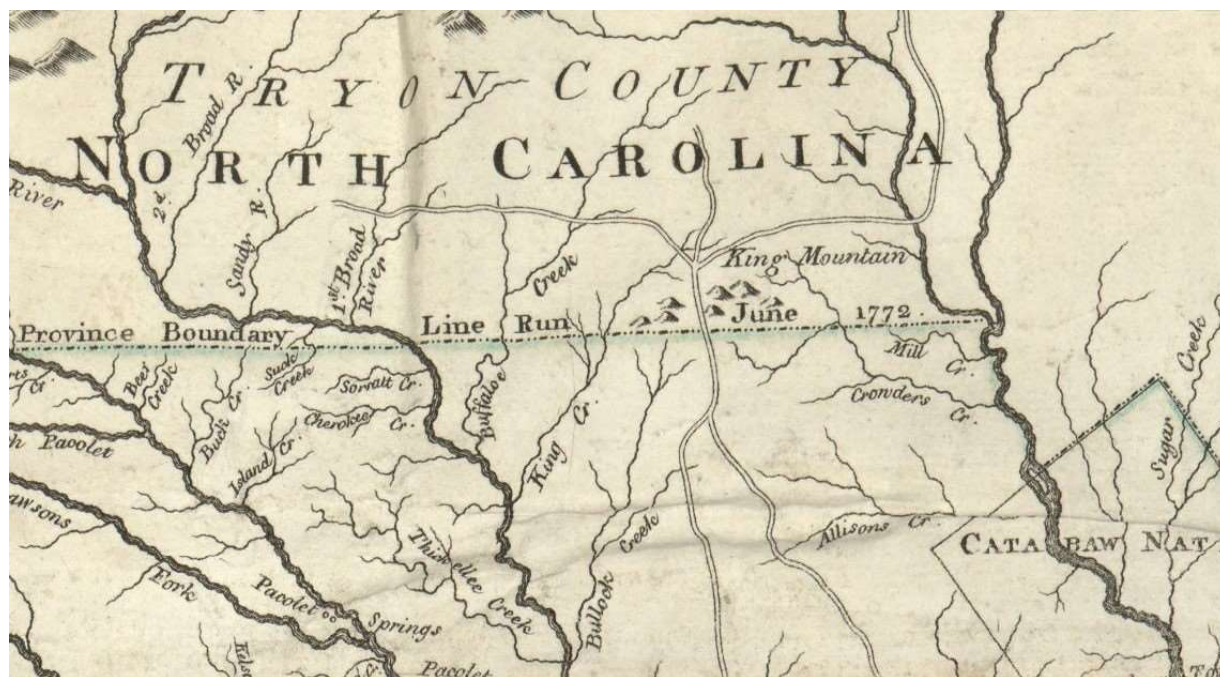

bordered by Crowder's Creek residents Elias Grimwell and Edward Walls²⁰ along with Robert Berry and James Gingles on Little Catawba Creek.²¹ In 1830-1831, the Mill Creek property was sold to William Hardman of York County SC.²²

Under the leadership of Captain Anderson Thomas, Drury served along the Broad River in the South Carolina (SC) Revolutionary War Militia. Thirty-five days of service were rendered beginning 7 December 1778. In Camden District SC on 10 January 1784, Drury appeared before David Hopkins, Justice of the Peace (J.P.), to establish and testify to Revolutionary War services. Compensation was awarded on 18 April 1785 and credited to service of Colonel David Hopkins.²³

For three decades, Drury was enumerated in Lincoln County NC Censuses and reflected an identified and presumed wife and children within the household.^{24 25 26 27} Unnamed children along with an unnamed widow were declared in Drury's Lincoln County NC Last Will and Testament, with two identified sons, Moses and Milton W.²⁸ Milton W was literate and executor of Drury's estate.²⁹ Resemblances of Milton's signature on three court documents; 1. Drury's Lincoln County NC estate filing, 2. Elijah Brown and Rachel Glen's Lincoln County NC 1827 marriage bond³⁰ and 3. Wilson County Tennessee (TN) 1823 marriage bond of Joseph Cuthrel and Margaret Springs³¹, provides evidence that Lincoln County NC Drury Grissom children migrated to middle TN. In the 1880 Macon County TN Mortality Schedule for Moses Grissom, the birth location for Moses's parents, i.e. Drury and Mary Sr, was NC.³² Drury's death occurred between 26 November 1827 and January 1829.³³ Mary Sr, the identified widow and mother of Moses and Milton W, remained in Lincoln County NC until at least 15 May 1830.³⁴

An incipient contextual perspective on the Drury Grissom family has been provided through the identification of family structural components. To restate, these components included; a. spousal characteristics including identity in 1792 as Mary Sr, NC birth location, death beyond 15 May 1830, and mother of three children, Mary Jr, Moses and Milton W, b. three identified children, Mary Jr, Moses and Milton W, c. geographic location in NC and SC, d. economic/occupational position specifically land ownership and laborer, e. patriot, and f. Drury, head of household, spouse, father, born in NC and death between 26 November 1827 and January 1829.

The undisclosed family structural components remain vast. Lincoln County NC ancestral documents beyond 1790 included many Grissom first names. Thus, the desire to address the undisclosed family components emerged.

Approach

An adaptation of the Neill framework³⁵ served as the basis for discovery, utilizing data from the Federal Censuses. The adapted framework directed an investigational purpose, inquiry assumptions and a method driven process with outcomes. The purpose was twofold; construct family structural components by demarcating identified and presumed children from the 1790, 1800, 1810 and 1820 Lincoln County NC Censuses^{36 37 38 39} and discern first names for the presumed children from additional ancestral documents.

Assumptions

Assumptions were needed to analyze pre-1850 census, since members were anonymous with the exception of head of household. Essential assumptions were offered as follows;

1. the ages reported for each male and female child remain consistent from year to year,⁴⁰
2. enumerated males and females born to the head of household remained in the household until death, marriage or establishment of their own household,⁴¹
3. if multiple males and females were reported within the same age range, different ages were represented,⁴²
4. to minimize the number of individuals who resided in the household during the entire thirty-year census timeframe, the censuses were analyzed and evaluated,⁴³
5. young males and females in the household were the children of the head of household,⁴⁴
6. variants of the name Drury Grissom; 1790 Lincoln County NC Census Drewry Grissom, 1800 Lincoln County NC Census Drury Grayson, 1810 Lincoln County NC Census Drury Gressom, and 1820 Lincoln County NC Census Drury Grisson, represent the same head of household,
7. parental testimony most accurately reveals male and female ages, and
8. Drury Grissom had only one wife, Mary Sr.

Method

Drury Grissom was enumerated in four Lincoln County NC Censuses between 1790 and 1820. Each census was analyzed in sequential order. Birthyear ranges were ascertained for Drury, Mary Sr along with male and female identified and presumed children. Identified and presumed children were designated as son or daughter and served with an alphabetic designation, i.e. "Son A", "Daughter A". The analysis of each census generated additional identified and presumed children.

A description of the 1790 through 1820 Lincoln County NC Censuses was offered to express birthyear ranges. In the 1790 census, ages of the white males were categorized as either under 16 years or 16 years and older. The under 16 years category implies the age was younger than or equal to 15 years.

Thus, a 15-year-old at the time of census enumeration, could turn 16 years after enumeration and therefore born in 1774 or 1775. Only one category existed for white females - white females in the household. Therefore, the females were born in 1790 or earlier.

In the 1800 Lincoln County NC Census, the male and female age categories were under 10 years, 10-15 years, 16-25 years, 26-44 years and 45 years and older. To be under 10 years implies the male or female is 9 years and under at the time of census enumeration so birthyear range would be 1791 to 1800. However, if the same male or female had a birthday after the enumeration date the birthyear range would be 1790-1800. Presenting both birthyear options would indicate consideration had been provided to those having a birthday after census enumeration and thus reflecting a birthyear range of 1790/1791-1800. If a male or female was enumerated at 10-15 years, the birthyear range would be 1785-1790 with the possibility of a 1784 birthdate if a birthday occurred after census enumeration. Consequently, the birthyear range would be most accurately presented as 1784/1785-1790. The same logic would be applicable to the 16-25 years range, and 26-44 years range. For individuals 45 years and older, the birth range was 1755 or earlier.

Age ranges in the 1810 Lincoln County NC Census repeat those in the 1800 Lincoln County NC Census. However, in the 1820 Lincoln County NC Census white male age ranges were; under 10 years, 10 and under 16 years, 16 and 18 years, 16 years and under 26 years, 26 years and under 45 years and over 45 years. Thus, white males of 16-18 years could have been placed in one of two categories or duplicated. White female children age ranges are different from white males in the 1820 Lincoln County NC Census. Birthyear ranges for white females were; under 10 years, 10 to under 16 years, 16 to under 26 years, 26 to under 45 years and over 45 years. Dual birthyears are offered for each of the males and females in all four of the Lincoln County NC Censuses for the Drury Grissom household. Of note, the national enumeration date was 7 August 1820 for the 1820 Census. Without regard to the actual enumeration date, possibility exists that identified or presumed children could have been enumerated twice, once in NC and again in another location.

For identified children, Mary Jr, Moses and Milton W, a son or daughter and alphabetic designation was applied. Name identification was pursued for the presumptive children by also using a son or daughter alphabetic designation. A two stage process was formulated to discern first names and disclose additional family structural components. Stage 1 involved the review of pre-1850 Lincoln County NC ancestral documents and stage 2, the examination of middle Tennessee (TN) documents.

In Stage 1, six ranked levels of Lincoln County NC ancestral documents were analyzed to achieve the highest level of certainty that the presumed children were the children of Drury and Mary Sr. These ranked levels included; a. Level 1 - family milestone event documents with the presumed child named with Drury and/or Mary Sr, b. Level 2 - documents with another presumed child and Drury and/or Mary Sr, c. Level 3 - documents with identified children Mary Jr, Moses and Milton W, named with presumed children, d. Level 4 - documents placing a presumed child in geographic proximity to Drury and Mary Sr, e. Level 5 - documents with two or more presumed children named within the same document, and f. Level 6 - documents with a sole presumed Grissom child.

In Stage 2, the process to discern the names of presumed Grissom children, included the examination of ancestral documents in middle TN, Wilson County. The Wilson County TN documents provided another tool to generate birthyears for presumed children. Two levels of analysis were advanced. In Stage 2 Level 1, documents were sought with the two identified male children of Drury and/or Mary Sr Grissom, Moses, and Milton W and other presumed children. In Level 2, Wilson County TN documents

The 1790 to 1820 Lincoln County NC Censuses enumerations produced birthyear approximations. Birthyear ranges were determined for each identified and presumed son and daughter with a corresponding alphabetic notation. Commonly occurring birthyears from each census yielded the range. To illustrate, Son A was enumerated in the 1790, 1800, and 1810 Lincoln County NC Censuses. In the 1790 Census the birthyear range for Son A was 1775-1790, 1775-1784 in the 1800 Census and in the 1810 Census, 1766-1784. Therefore, the birthyear range was 1775-1784. The birthyear(s) trailing the identified and presumed child name was obtained from ancestral documents beyond the 1820 Lincoln County NC Census with the exception of Mary Jr (Daughter A). The asterisk signifies an identified child.

In Stage 1 the pre-1850 Lincoln County NC ancestral document review commenced to obtain first names of a presumed child naming and achieved at six analytic levels. In Level 1, family milestone life events were located that supplied the researcher with the highest level of certainty that the presumed child named with Drury and/or Mary Sr was their child. Two documents located; 1. Hannah Fininger Grissom and Thomas Rogers (Daughter C) marriage bond of 500 pounds of lawful money in the State of NC on 30 September 1802, Drury D. Grissom, bondsman, ⁶³ and 2. William Grissom's (Son A) baseborn child in Court of Pleas and Quarter Sessions of January 1812⁶⁴, named two presumed children as Hannah Fininger (Daughter C) and William (Son A). In Level 2 a presumed child was named if the presumed child was in the same document with either Drury or Mary Sr. Three documents located; 1819 and 1821 ^{65 66} tax documents with Martin (Son B) and William (Son A) and the NC State witness document identified both Drury and Mary Sr with Martin (Son B). ⁶⁷In Level 3, previously identified children Mary Jr (Daughter A), Moses (Son F) and Milton W (Son J) were matched with presumed children in the same document. One document was located, the Last Will and Testament of John Glen dated 13 Aug 1828,

that names Mary Jr (Daughter A) as wife and son of John Glen, David Glen.⁶⁸ David Glen was the spouse of Elizabeth,⁶⁹ (Daughter D) presumed sister of Mary Jr (Daughter A). Level 4 documents with presumed children in geographic proximity to Drury and Mary Sr were considered for analysis. Five documents included; 1. Thomas (Son D) 13 September 1806 land deed⁷⁰, 2. Elizabeth P. (Daughter D) 6 October 1807 Last Will and Testament of John Baird (neighbor of Drury)^{71 72}, 3. William (Son A) 11 September 1811 land deed⁷³, 4. Martin (Son B) 30 September 1822 land deed⁷⁴ and 5. William (Son A) 1 September 1810 Crowder's Branch land sale between Thomas (Son D) and Benjamin (Son E)⁷⁵. In Level 5, two or more presumed children in the same document were considered in child naming. The marriage bond of Benjamin Grissom (Son E) with Mrs. Jememiah Bell dated 18 August 1808, was evaluated with Thomas (Son D) providing the surety.⁷⁶ In Level 6, ancestral documents were considered when only one presumed child was named. Documents included; Rowland W. (Son C) 2 October 1804 Court Session, Jul 1811 Court Session⁷⁷, Sophia (Daughter B) 1 January 1808 marriage bond with James Bell⁷⁸, and Sarah (Daughter F) 6 February 1816 marriage bond with Benjamin Slate.⁷⁹

In summary at the completion of Stage 1 with six levels of analysis, presented serially are the presumed children with the greatest propensity to be the children of Drury and Mary Sr, include; Hannah Fininger (Daughter C), William (Son A), Martin (Son B), Elizabeth (Daughter D), Thomas (Son D), Benjamin (Son E), Rowland W (Son C), Sophia (Daughter B) and Sarah (Daughter F). Thus, the remaining unnamed children included; Son G, Son H, Son I, Daughter E and Daughter G.

The Stage 2 analysis to name presumed Drury and Mary Sr children, ancestral documents in middle TN were examined. In Level 1 of Stage 2, the two identified children Moses (Son F) and Milton W (Son J) were matched with other presumed children. The only document located was the 1820 Wilson County TN Census.⁸⁰ In addition to the enumeration of Moses (Son F), four presumed male children were enumerated and included Thomas Grisham (Son D), Benjamin Grisham (Son E), Phillip Grisham (Son G) and James Grisham (Son H). The spouses of three presumed female children were also enumerated; Thomas Rogers husband of Hannah Fininger (Daughter C), James Bell husband of Sophia

(Daughter B), Benjamin Slate husband of Sarah (Daughter F). In Stage 2 Level 2, the identity of two presumed children not located in Lincoln County NC was sought and produced the names of two presumed sons, Phillip (Son G) and James (Son H). Both Phillip (Son G) and James (Son H) were located. James (Son H) was identified in the 26 May 1826 estate documents of Thomas Rogers, spouse of Hannah (Daughter C) ⁸¹ along with Benjamin Slate, spouse of Sarah (Daughter F) and Rowland W (Son C). James (Son H) also provided surety in the marriage of Patsy Rogers, daughter of Hannah Fininger (Daughter C), ⁸² to William Coonrood 22 April 1822. ^{83 84} Philip (Son G) and Sally Spring's 14 January 1822 Wilson County TN marriage bond ⁸⁵, with the surety of Rowland W (Son C) was the only document identified for Phillip (Son G) with another presumed child. At the conclusion of Stages 1 and 2 to name presumed children, Phillip (Son G) and James (Son H) were named with confidence as the sons of Drury and Mary Sr. Son I, Daughter E and Daughter G remain unnamed presumed children of Drury and Mary Sr Grissom.

Summary

The adapted version of the Neill framework broadened the contextual perspective of the Drury Grissom household by enhancing family structural components and enabled the discovery of undisclosed components. Both Drury and Mary Sr were born in 1755 or earlier and Mary's last child Milton W (Son J) was born when Mary Sr was about 47 years of age or older.

Newly discovered family structural components included the addition of 14 children with name discernment for eleven of the 14; William (Son A), Martin (Son B), Rowland W (Son C), Thomas (Son D), Benjamin (Son E), Phillip (Son G), James (Son H), Sophia (Daughter B), Hannah Fininger (Daughter C), Elizabeth (Daughter D) and Sarah (Daughter F). Thus, three presumed children unnamed (Son I, Daughter E and Daughter G) died, married or moved to another household prior to identification.

Recommendations

In pursuing the identity of Son I, Daughter E and Daughter G, suggestions are proposed. Suggestions include; continued pursuit of Lincoln County NC and Wilson County TN ancestral documents. These documents should include; family and county histories, deaths, marriage and cemetery documents. With the steady migration of the identified and named Drury Grissom children, special attention should be devoted to documents in these United States locations; Ripley County, Missouri, Bartholomew and Posey Counties, Indiana, Itawando County, Mississippi, Franklin County, Alabama and Illinois.

Additional information on each of the identified and named children is provided. Refer to the appendix to aid in the further development of the Drury and Mary Sr family structure.
