

Gent., of Little Stainbridge, Essex, 3rd son of Sir James Bouchier of Little Stainbridge, and younger bro. of Elizabeth Bouchier who m. Oliver Cromwell, Lord Protector of England; and JOHN, b. 1618.

**4. JOHN NUTTALL**, son of James (3) and Jane (Wiseman) Nuttall, was b. 1618, and d. 1667. He m. 1st, Rebecca Bright of Great Warley, Essex, dau. of Robert Bright, June 1642; m. 2nd Elizabeth Bacon Holloway, widow of Dr. John Holloway; in Jan or Feb 1644 in Northampton Co., VA; m. 3rd, 12 Sep 1660, Jane Johnson in Hunger's Parish, Northampton Co., VA.

Lindsay Nuttall states that the Virginia settler is usually identified as a son of John Nuttall and Mary Hyde, daughter of Robert Hyde of Norbury, Cheshire, because of a letter written by one Phillips in 1645 referring to Mr. Nuttall, his mother, father and sister in London. Researchers have assumed that Mr. Nuttall was the settler John, but Lindsay Nuttall states that the settler was still in England at this time.

On 27 July 1645 John Nuthall was granted 300 acres of land in Northampton Co. for transporting 600 persons: himself twice, his wife Elizabeth, John Towson, Andrew Ditch and John Evers. John Nuthall probably married Elizabeth, widow of Dr. John Holloway, but the compiler of this work has found no proof that she was Elizabeth Bacon, sister of Hon. Nathaniel Bacon. About 1661 Nuthall settled in MD and purchased 400 acres of land comprising St. Elizabeth's Manor and Cross Manor (*ARMD* 51:103).

Nuthall died intestate some time prior to 10 Oct 1667 when his estate was appraised. In 1668 the Council of Maryland ordered that his personal estate was to be divided among his three children: John, James, and Eleanor Nuthall now wife of Thomas Sprigg (*ARMD* 5:34).

John and Elizabeth (Bacon? Holloway?) Nuthall were the parents of (B): JOHN, b. c1648; ELEANOR, b. 1646, m. by 1668 Thomas Sprigg; JAMES, d. 1685; m. the Widow Margaret Bolton; and ELIAS, may have married Elizabeth Beckwith (*MHM* 16:289).

**5. JOHN NUTHALL, Jr.**, son of John (4) and Elizabeth, was b. c1648 and d. 1714 in Maryland. His age is established by a deposition he made in 1669 giving his age as 21 (*ARMD* 60:215).

Adams goes on to say that Nuthall's first wife died after the birth of their son John, and he later married Mary Brent of Stafford Co., Va., but she also died before her husband. John Nuthall died leaving a will made 22 Nov 1713 and proved Sep 1714. In his will he named his grandchildren Brent Nuthall and Eleanor Nuthall, and his own son John.

In 1668 young Nuthall sold Cross Manor and St. Elizabeth's Manor to Mark Cordea. In 1675 he and his brother James testified on behalf of their brother-in-law Thomas Sprigg (*ARMD* 51:156, 168, 175). Nuthall may have married as his first wife Barbara (N), but Adams states that definite proof of this is lacking. Nevertheless, on 15 Nov 1668 John Nuthall of CV Co., Md., (son of John Nuthall of SM Co., dec.), and Barbara Nuthall, wife of the younger John Nuthall, conv. to Elizabeth Baker of SM Co., land in SM Co. called The Town Land, formerly granted to William Lewis, for 200 acres (*PCLR WRC#1:492*).

John Nuthall was the father of (B): JOHN, m. Eleanor Sprigg Hillary, widow of Thomas Hillary.

**6. JOHN NUTHALL**, son of John (5), possibly by his first wife Barbara, was b. c1675, and was brought up by his father's second wife Mary Brent. He
