Descendants of Samuel Allen

Of Windsor, Conn.

1640---1907.

WE were given to understand by the early genealogical writers that Samuel Allen, who settled in Windsor, Conn., in 1640, came from Braintree Co., Essex, England, where he was born in 1588, and came to Cambridge, Mass., in 1632, and that he was a brother of Col. Matthew Allen, etc.

In the introduction to this work it has been clearly shown that he was not a brother of Col. Matthew Allen, and later investigations have shown that the Samuel who came to Cambridge in 1632 was the one who later settled at Braintree, Mass.

As yet no records have been found which clearly point out the ancestry of our Samuel Allen, where or when he was born, or just when he migrated to this country, yet from all the known circumstances connected with him, I am inclined to adopt the theory of Mr. Francis Olcott Allen, who has given the subject much thought, that he came over with the Dauchester Company in 1630, and settled primarily at Dorchester. The reason that the present Dorchester records do not mention his name is probably due to the fact that the first leaves of said record are missing; and allusion is also made to a missing book containing names of the grantees from the beginning.

This belief was shared by William Allen, D. D., of Northampton, who says in a note to *Christian Sonnets*, published in 1860, that his ancestor, Samuel Allen, "Is supposed to have come from the west of England with the Dorchester people in the ship *Mary and John* in 1630." Dr. Allen was greatly interested in the ancestry of his family, and gave the subject much thought, so his testimony is the more valuable.

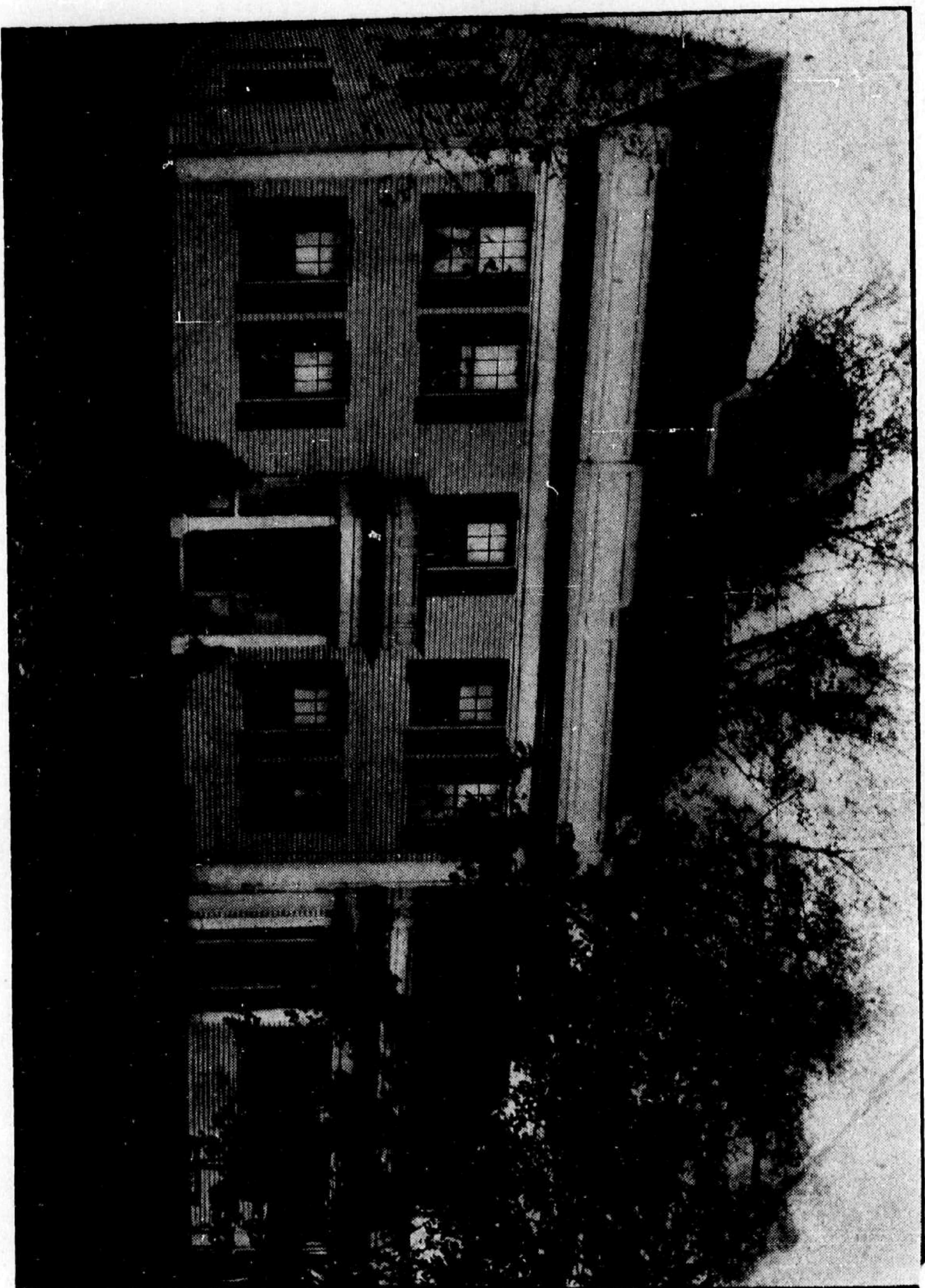
Windsor was largely settled by Dorchester people, which fact strengthens our belief that Samuel Allen was from that source. However, the first undoubted official record of Samuel Allen is found in the Windsor land records as follows :

“January 27, 1640, Samuel Allen hath granted from the plantation at Windsor, Conn., 1st An house lot, being six acres, three rods, ten poles, bounded from the rivulet to the west by Rodger Ludlow on the south, by Thomas Marshall on the north, and runs in length to the west into a highway laid out into some part of the lot of said Rodger Ludlow and his, the said Samuel Allen.

2d In Plymouth meadow, four acres, bounded by Bray Rossiter on the north and a rivulet that runs into the great river on the south. 3d Toward Hartford, nineteen acres, more or less, and runs in length to the Great River to the west one hundred and thirty and four rods, and is bounded by John Witchfield on the north and by Thomas Marshfield on the south. 4th Over the Great River next to the same, fifteen rods in bredth, in the length to the east three miles ; bounded by Joseph Lumus on the south, John Hurd on the north.”

The best view of the homestead site of Samuel Allen has been procured at the suggestion of Mr. James Allen Kibbe, who says it is now occupied by the Windsor Public Library, a very old house which stands on the second house lot bought by Samuel Allen in 1641 of James Marshall, as shown in the accompanying illustration. This will serve to fix the exact location where Samuel Allen lived.

But little has come down to us of Samuel Allen save that he was a farmer, was a man of public spirit, and was chosen a juryman March 5, 1644. He was buried in Windsor April 28, 1648, and is said to have been 60 years of age, but no proof is given for the statement, and from the fact that his widow survived him 39 years, it may well be inferred that from 35 to 40 years would be nearer to his correct age. His property inventoried Sept. 8, 1648, at £76, 18s. 8p. The widow, Ann Allen, (maiden name unknown) married (date not given) William Hurlbut, who also had settled in Windsor, and was from Dorchester. They removed to Northampton, Mass., in 1657, taking the Allen children with them. Ann (Allen) Hurlbut d. Nov. 13, 1687 ; William Hurlbut d. Apr. 17, 1694 ; their ages are not given. It is doubtful if children were born to them after the second marriage.

2. SAMUEL² ALLEN (*Samuel*¹), b. 1634; m. Nov. 29, 1659, Hannah, dau. of Thomas and Mary (Blott) Woodford of Northampton. Mary Blott was a dau. of Robert. "Samuel Allen came to Northampton in 1657. A public meeting of the settlers held Dec. 19, 1657, assigned him a home lot on King street. The house soon reared upon it, having received at intervals many additions and improvements, stood on the left hand corner of what is now called Edwards street, but formerly by name less historic, viz: Back Lane. In 1659, the house being in readiness, he married the daughter of his next neighbor on the south. This homestead remained in the line of his descendants till 1805, a period of 150 years.† He was made freeman 1683. He died in Northampton Oct. 18, 1719.

to Northampton, where he d. June 27, 1684. He was a constable in Northampton in 1672. His estate inventoried July 23, 1684, at £420-8. His widow m. (2) Sept. 1, 1687, Richard Burke. She m. (3) July 11, 1706, Judah Wright, and d. Mar. 31, 1712-13.

8. THOMAS³ ALLEN (*Samuel², Samuel¹*), b. Feb., 1680-1. Have been unable to find any record of his marriage, but in his will, made June 28, 1754, he alludes to first wife and to children of second wife deceased, from which we may infer that he had no living children at that time. He probably died soon after 1754. In his will he devised certain amounts to the following, viz: "To my nephew Jonathan Allen of Middletown; nephew Samuel Allen of New Marlboro; niece Thankful Alexander; Thomas Holton of Farmington; Samuel Fairfield and Patience Severance, wife of Martin Severance; Mary, wife of Joseph Stebbins of Northfield, and dau. of my wife late deceased; Ebenezer Williams of Hadley, son of my late dear wife; my niece Mary, wife of Daniel King of

Northampton, for care of my first wife ; Thomas Allen, son of my nephew Joseph Allen, £133-6-8, to assist him in obtaining a liberal education at one of the colleges." (This alludes to the future Rev. Thomas Allen of Pittsfield). Joseph Allen, his nephew, was made executor of his will (see book 8, page 96, Probate Records at Northampton).

With the aid of the above will and published genealogies it seems that Thomas Allen's second wife was Sarah, dau. of William Arms, b. Nov. 21, 1681, who had m. May 2, 1700, Zebediah Williams ; she m. (2) Jan. 28, 1707-8, Samuel Jones of Northfield, and m. (3) Thomas Allen, date not given.

Mar. 14, 1669, dau. of Judah and Mercy Wright of Northampton.* Mercy, wife of Judah Wright, was the daughter of Henry and Eulalia Burt, the English emigrants to Springfield, Mass.† Samuel Allen was first of Northampton ; he removed thence to Deerfield, where on Dec. 8, 1705, he bought of Samuel Carter the lot later known as the Dr. Willard place, now opposite the Unitarian church. Carter had bought the place in 1694 with a house on it. The present Dr. Willard house was built in 1768 by Joseph Barnard. In the rear of this house is a small ell,

*Dea. Samuel Wright, the emigrant, was descended from John Wright of Kelvedon Co., Essex, Eng., and is found in Springfield, Mass., Dec. 12, 1639, where he soon became deacon of the first church there. very ancient in appearance and construction, which is probably the same house bought by Samuel Allen, and in which Joseph Allen, the father of Gen. Ethen Allen, was born. Hon. George Sheldon writes me that while there is no direct evidence of this, yet it is highly probable, for he was certainly born on this place, if not in the old house now standing. Samuel Allen sold this place in 1711 to Samuel Barnard and bought the Hawks place in Wapping, which in turn he sold in 1713 and soon removed to Coventry, Conn.,* where he d. Oct. 14, 1718. In 1720 his widow, with her children, removed to Litchfield, Conn., where she d. Feb. 5, 1728, ae. 59. She inherited some property from her father's estate, for we find years afterward that her children sold their several interests to their uncles, Judah and Ebenezer Wright of Northampton. She purchased quite a large tract of land in Litchfield, for on her death her son Daniel, as executor, conveyed March 1, 1729, one-third of the same to his brother Joseph, who in 1732 sold one hundred acres to his sister, Lydia, and the same amount to Paul Peak Jr. The will of Mercy Allen was made in Litchfield Jan. 28, 1727-8, and probated Apr. 24, 1728, in Woodbury. She gives her son Daniel quite liberally, and makes him sole executor. Her remaining estate she divides among her children and mentions dau. Mercy, wife of Eliakim Root of Coventry; dau. Mary Smalley of Lebanon; dau. Lydia Allen at home; sons Joseph and Ebenezer of Litchfield; no mention is made of Lucy, who was doubtless deceased but alive when the removal was made to Litchfield. The eldest son, Nehemiah of Guilford, was appointed guardian to brother Joseph, and Daniel to brother Ebenezer. The final settlement has not been found on record.

John Allen is said to have come from Deerfield, Mass., about 1690 and located in Enfield, on the farm just allotted to Tahan Grant,

which was forfeited by him for non-settlement. About 1696 he removed and located on the Saltonstall farm on Kings street, which farm extended westward nearly or quite to the Conn. river.* The farm has remained in the Allen family to this day.

In 1697 " the town exsep of Samuel Allen as inhabitent in the town and grant to him eleven acres of field Land & two of medow on condison he cum & settel."† In 1698 the boundary of his land is given as adjoining on the north of the farm of his brother John on Kings street, and extended west to the great river. This farm has lately been known as the Chauncy Allen farm. The farm remained in the hands of Samuel's descendants until a few years ago. Samuel Allen was chosen constable in 1715. He d. 1735.

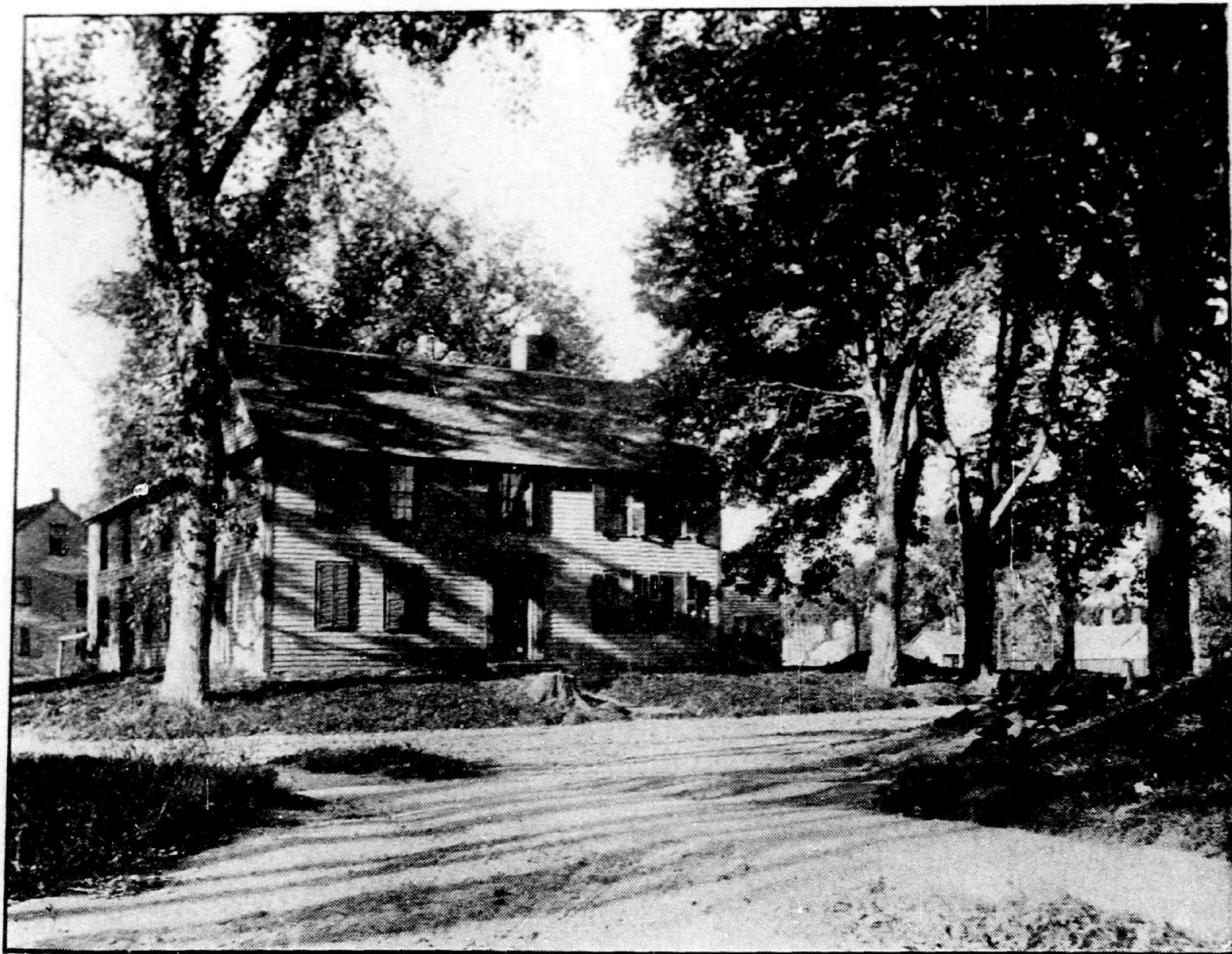

She was a dau. of Noah and Mindwell Edwards Parsons of Northampton. Joseph Allen d. Dec. 30, 1779; his wife Elizabeth d. June 10, 1800. Joseph Allen and his wife were grand types of the old New England stock of Christian men and women, who gave character and nobility to the community in which they

moved. They were the parents of fourteen children, ten of whom lived to marry and have families. Six sons were patriots and had notable service in the Revolutionary War, and left records worthy of fame. Joseph Allen was a staunch friend of Jonathan Edwards, and was one of the nineteen who stood by him during all his difficulties with his church.

Betty Allen was truly a mother in Israel, a woman of service and general usefulness, for the church records show that she assisted at the births of three thousand infants. She was also a woman of faith and believed in the efficacy of prayer. Her husband's uncle, Thomas Allen, had devised in his will money to defray the expenses of a college education for their son Thomas, which bequest was to be contested at Boston, where her husband had gone to plead the case for his son. Betty and her daughter spent the day in prayer when the case came on, and it was decided in their favor, and the son Thomas was given the liberal education which meant so much to his after life and that of his noble family.

With the knowledge of the long and noble life of Betty Allen and of the six patriot sons she gave to the service of her country, it is a worthy tribute to her memory that the Northampton Chapter of the Daughters of the American Revolution has adopted her name.*

Joseph Allen took his young bride to his home on King street, first owned by his grandfather, Samuel Allen, where he lived till his death, and where his wife continued to live sixty-six years in all; so it came to be known as the "Betty Allen house;" it stood quite near the home of Jonathan Edwards. Their son Elisha continued to live in this house till his death in 1796. His widow, Merab Allen, lived there till 1805, when she married Oliver Root of Conway. Jonathan, son of Elisha, the last of the line associated with the house, sold soon after 1800 and removed to Pittsfield after being in the Allen family 150 years. It was enlarged several times during this period, but is remembered as a pleasant home shaded by hemlock trees.

Dr. Benjamin Barrett lived there after his marriage. Mrs. Rhoda Dwight lived there later, and her daughter Margarette opened there her boarding school, afterward famous as Gothic Seminary; later

Col. A. E. Watson owned the house. The next owner was John W. Wilson, who sold it in 1858 to Oscar Edwards, now president of the Northampton National Bank, who lived there five years. The house was torn down about 1900.*

63. HANNAH⁵ ALLEN, (*Joseph⁴, Samuel³, John², Samuel¹*), b. in Enfield June 13, 1725; m. Jan. 30, 1746, Caleb Booth, son of Caleb and Mary (Gleason) Booth, b. in E. Windsor Sept. 13, 1724, d. there Sept 29, 1772; she d. Nov. 22, 1779. This Booth family is descended from Robert Booth, who came from England about 1640 and settled in Saco, Me.

The above Col. Caleb Booth, on the receipt of the news of the battle at Lexington, marched with the North Parish Train Band of

East Windsor for the relief of Boston. Learning at Shrewsbury that the period of immediate danger was past he returned home with the majority of the company, having been absent four days. He was commissioned a Lieutenant in 1783; Captain of the fourth Co. of Town Militia in 19th Regt. in 1784; Major in same 1793; Lt. Col. 1796. After the close of the war he served seventeen terms in the Connecticut Legislature from E. Windsor; also rendered most valuable service to his own town. He was also a local justice. The house is still standing which he built in 1773. He married May 1, 1774, Ann, dau. of Capt. Jonathan and Hannah (Watson) (Bissell) Bartlett. He d. at E. Windsor, Sept. 10, 1830. His wife was b. Mar. 24, 1751; d. Apr. 20, 1803. Had eight children, viz.: Anne, Caleb, Gaius, Hannah, (Rev.) Chauncy, Henry, Betsey and Sabra.

The above Rev. Chauncy Booth, b. Mar. 15, 1783; m. Nov. 16, 1815, Laura Farnum, b. 1792, d. 1875. He graduated from Yale College 1810, Andover 1813; settled over First Congregational church, Coventry, Conn., 1815, where he served acceptably till failing health caused him to ask for dismissal in 1844. He stood well in the ministry; d. S. Coventry, Conn., May 24, 1851. Had 10 children, viz.: Chauncy (M. D.), Laura F., Henry F., Elizabeth, Caleb, Thomas F., Henry M. (M. D.), Kirtland F., William H., son unnamed, Ellen Maria, b. Sept. 2, 1836, m. May 8, 1879, Dr. Pardon H. Derby, resides in Springfield, Mass. She is a member of the D. A. R., and has furnished much of the information of the Booth family as presented above.
