

by the Lady Eleanor Plantagenet, dau. of Henry, 3rd Earl of Lancaster, fourth son of King Henry III, by Eleanor, dau. and co-heir of Raymond, Count of Provence. Sir Thomas who took the Lancastrian side during the Wars of the Roses, was besieged in the Tower of London by the Yorkist Earls, 10 July, 1460, and eventually with five others was hanged, drawn and quartered at Tyburn, 29 July, 1460, leaving issue,

SIR GEORGE BROWNE, of Betchworth Castle, Surrey, Knighted by King Edward IV after the battle of Tewkesbury, 4 May, 1471, but in after years was involved in the revolt of the Duke of Buckingham against King Richard III. John Paston, his nephew by marriage, wrote thus of Sir George: *This I think to do when I come to London, to speke with my Lord Chamberleyn and try to win by some means to cause the King to take my service through Sir George Browne who waytes most upon the King, and lies nightly in his Chambers.* Sir George m. Elizabeth (will pr. 1488, she being therein described as of Blackfriars, London, and Dorking, Surrey), dau. of Sir William Paston, Judge of the Court of Common Pleas (by Agnes, dau. and co-heir of Sir Edmund Berry, Kt.), and widow of Richard, Lord Poyning, and was beheaded on Tower Hill, 4 Dec. 1483, and was s. by his son,

SIR MATTHEW BROWNE, of Betchworth Castle, M.P. for Surrey, 1495, 1539, went on the expedition to Guelderland 1512, waited on the Queen at the Field of Cloth of Gold 1520, and attended with fifty men to aid in the suppression of the Northern Rebellion 1536, b. 1473; m. Frideswide, dau. of Sir Richard Guildford, K.G., M.P., and d. 6 Aug. 1557, leaving issue,

1. Henry, who m. 1st, Mary, dau. of John Fitzherbert, and by her had issue,

r. Philip, heir to his grandfather in 1557, b. ca. 1530, but d.s.p. and was s. by his brother.

He m. 2ndly, Catherine, dau. of Sir William Shelley, of Michelgrove, Sussex (see BURKE'S *Peerage*, SHELLEY, Br.), by Alice, eldest dau. of Sir Hamon Belknap, and d.v.p., having by her had issue,

Thomas, of Betchworth Castle, grandfather of Sir Ambrose Browne (created a Baronet 7 July, 1627, which title became extinct on the death of the 2nd Bt.), and father by his second wife, Mabel, dau. and heir of Sir William FitzWilliams, of Elizabeth, who m. Robert Honeywood, from whose papers the descent of Edward Browne, of Maryland from the Brownes of Betchworth Castle has been deduced.

EDWARD BROWNE, b. 1605; whose son by Alice, his wife, EDWARD BROWNE, of London, and afterwards of the Isle of Kent, Maryland, whither he emigrated in 1655 at the instigation of his relative William Piper, bapt. in London 1632; m. Sarah, dau. of Morgan Williams, and d. 1678, leaving a son,

EDWARD BROWNE, of the Isle of Kent, Maryland, b. 1678; m. Mary, dau. of John Erickson, and d. 1716. His son,

MAJOR JOHN BROWNE, of Kent Co., Maryland, b. 1699; m. Jane, dau. of Capt. Thomas de Courcy, and d. 1747, leaving issue,

WILLIAM BROWN, of Kent Co., Maryland, b. 1738; m. Anne, dau. of Joseph Wickes, and d. 1795. His son,

THOMAS BROWN, of Kent Co., Md., b. 1786; m. 1806, Elizabeth Richardson, of St. Mary's Co., Md., and d. 1809, and was father of THOMAS RICHARDSON BROWN, of Kent Co., Md., b. 3 Mar. 1807; m. Mary Elizabeth, dau. of Thomas Bowers Hyason, of Kent Co., Md., and d. 25 Dec. 1871, leaving issue,
